## **Golf Car Rental Agreement**

The following paragraph has been reproduced from our Golf Car Rental Agreement. Below it has been adapted to fit a group outing where the **sponsoring group will assume responsibility** for the participants involved in their event day.

#### **GENERAL TERMS OF RENTAL**

In consideration of the rental of this golf cart, I agree to:

- 1. Leave the cart in as good a condition as I received it.
- 2. Reimburse the owner for or pay for any damages sustained to the cart during this rental period.
- 3. Defend, indemnify and hold the owner & his agents harmless from and against all claims, suits and liabilities, without limiting the generality of the foregoing, for any and all damages to property or person, including, but not limited to injury, death, or damage to any property whatsoever, caused by, arising from, incident to, connected with, growing out of, or related to the use and/or operation of this golf cart during this rental.

As the sponsoring organization of a golf outing at Turtle Creek Golf Course, I hereby:

- 1. agrees to hold harmless, indemnify and defend Turtle Creek Golf Course and its owners and agents from and against any and all injuries and damages of any kind whatsoever to any person or entity arising out of or in any way resulting from the negligence or reckless use or operation of the subject golf cart;
- 2. agrees to reimburse Turtle Creek Golf Course for any such injury or damage done to any golf carts;
- 3. agrees not to allow any person not of legal driving status to operate a golf cart.

Signature of the Tournament Coordinator on the front of this contract will constitute compliance with the golf car rental agreement stated above.

# Turtle Creek Golf Course Tee Time Outing Information 2024

All tee time outings require a \$250.00 deposit; along with the signed contract.

Less than a 5-day notification of cancellation will result in forfeiture of the entire deposit amount.

A final count of participants is due **7** days prior to the event. Email Sandy Waltz at swaltz@turtlecreekgolf.com or call and ask for Sandy at 610-489-5133. This final count number will be used for billing purposes.

All food and beverages (alcoholic and non-alcoholic) must be purchased on site, no exceptions. No coolers are allowed on the course. We do offer a grill that serves hot dogs, hamburgers, and sandwiches on a daily basis.

A copy of Turtle Creek Golf Course rules is included. It is the responsibility of the undersigned outing representative to communicate these requirements to all outing participants.

In case of inclement weather, where the golf course is deemed unsafe or unplayable by the golf course management, the outing may be rescheduled. **Please note, cart restrictions on the golf course does not constitute a cancellation.** 

The person reserving the golf course pursuant to this contract shall be responsible for all damage to golf carts, property and/or persons caused by outing participants. Please refer to the back of the signature page of the contract for details on the golf cart rental agreement.

## **Turtle Creek Golf Course Rules and Regulations 2024**

All players must register with the pro shop before starting and obtain a valid receipt.

Proper attire required: shoes, soft spikes, golf shirt with a collar. Inappropriate clothing includes: tee-shirts, tank tops, sweatshirts, sweatpants, hoodies, and jeans.

All food and beverages must be purchased on site. **Personal coolers are not permitted.** 

Golf cart operators must possess a valid driver's license and be at least 21 years of age. The maximum is two players per cart.

All players must have their own clubs. Sharing of clubs is not permitted. Rentals are available for \$25.00.

Children under the age of 14 are not permitted on the golf course unless they are playing and have their own set of clubs.

Non-playing participants must pay a stipend of \$25.00 to be permitted on the course.

Rain checks are issued only if course is closed due to weather.

Observe proper golf etiquette: repair ball marks, replace divots and rake bunkers, USGA Rules of golf govern all play, except where modified by local rules.
